Mayor Talerico called the meeting to order at 6:59 PM followed by the pledge of allegiance and roll call.

Present: Mayor Ernie Talerico, Trustee Edwards, Trustee Chamberlain, Trustee Copperwheat – Trustee Kulpa was on a ZOOM call

Before beginning the meeting, Mayor Talerico outlined the Board's achievements since taking office in 2020. He thanked the Village Employees and also the surrounding towns and village for their working relationships as well as Oneida County.

He explained that the residents in the house are using the backyard as a toilet. He would like the Village to look into whether or not there is running water at the property as well as advising them that it is a health concern. Codes Enforcement Officer John Constas set up a time to meet Mr. Tramacerra at his residence and investigate what was going on.

Theresa Cattadoris – 206 Comenale Crescent – addressed Codes Enforcement Officer Constas with regards to 205 Comenale Crescent. She wants to make the Board aware that there are still several ongoing issues at the residence. Also, she is concerned with the high grass growing in the empty lots.

Tim Wilcox – 8 Wetmore Street – Tim advised the Board that there are several problems in his neighborhood with youths in the evenings. Also, he is concerned about people putting
