(Old item) Radios - We still need to purchase digital radios. Oneida County recently decommissioned analog radios on Oct 6 which means the firefighters/EMTs who currently carry those radios and the vehicles that only have analog mobile radios will not be able to contact Fire Control. **UPDATE:** We are looking at pricing options.

(Update) Holmatro tool – the cutter tool was damaged at a recent training session. We will be contacting the vendor concerning repairs. The manufacturer no longer provides replacement cutting blades for our cutting tool due to its age. We are pricing out alternatives. **UPDATE:** We attempted to obtain a cutter tool from the Terry Ferrell Fund Foundation, but none were available. We will need to purchase a used cutter. Expected cost is about \$6500.
